The Port's waiting list policy requires that a \$25.00 fee be returned with the Application for Moorage. *The date we receive the completed application and fee is the date you will be put on the waiting list.*

There are four levels to the Waiting List. Available slips are offered in the following order:

First, to current Marina tenants living within the Port District, who are waiting for a More appropriate slip; *

Second, to current Marina tenants living outside the Port District, who are waiting for a More appropriate slip; *

Third, to non-tenants living within the Port District; and

Fourth, to non-tenants living outside of the Port District.

If you are not currently a Marina tenant, but are interested in being placed on the Waiting List, please fill in the Application for Moorage and return it with the \$25.00 fee.

The \$25.00 fee is not required for current Marina tenants. If a tenant terminates their lease but wishes to remain on the Waiting List, the fee must be paid.

You will be notified when moorage is available, and will be offered a slip **once** so please be as specific as possible when making your request. Please keep your contact information updated. Please feel free to check your status on the Waiting List whenever you like.

***Tenants moving from one slip to another at their request are charged a \$30.00 relocation fee.**
